DIRECTORS' REPORT

for the financial year ended 31 December 2021

The directors present their report and the audited financial statements for the financial year ended 31 December 2021.

Principal Activity

Waterford Hospice Movement CLG, (WHM) was established in 1988 to provide a Hospice Homecare Palliative Care service to the people of Waterford City & County, and South Kilkenny. The Hospice Movement is a registered charity, Charity No 20022495 and operates from its offices in the South East Palliative Care Centre located on the grounds of University Hospital Waterford (UHW).

All Board members give their time voluntarily and receive no salary or expenses. The Board ensures activities remain consistent with the Charitable purpose and Objects commensurate with ensuring the provision of a Specialist Palliative Care Service in the Community up to the transfer of governance of this Clinical Service to the HSE on 31 May 2021, and thereafter the continued support of the Palliative Service via the provision of patient comforts, equipment and amenities and the provision of Complementary Therapy Services. Day to day operational Management is the responsibility of the Manager who is an employee of the company.

Up to 31 May 2021 our primary focus was the provision of a Hospice Home Care Services, for which the annual running costs are (in the region) circa €725,000 and WHM was funded by a HSE Annual grant of €249,000 with the balance of costs met via Donations & Fundraising.

WHM CLG provided the Specialist Palliative Care Home Care Service since its establishment in 1988 and would like to acknowledge the Volunteers, Donors and Fundraisers for its support in sustaining the clinical Service until its transfer to the HSE following the opening of the Southeast Palliative Care Service which includes a 20 bedded in patient Unit as well as providing governance for the Community Specialist Palliative Care Homecare Team previously employed by us. WHM CLG would also like to acknowledge its Donors and Fundraisers for the attainment of the €6m commitment in respect of the Capital Costs of this Building.

Financial Results

The (deficit)/surplus for the financial year amounted to €(817,052) (2020 - €277,325).

At the end of the financial year, the company has assets of €632,026 (2020 - €1,556,752) and liabilities of €6,611 (2020 - €105,915). The net assets of the company have decreased by €(825,422).

Going Concern

Waterford Hospice Movement CLG has been partially funded by the HSE via a formal Grant Aid Agreement. Accordingly, the financial statements have been prepared on a going concern basis.

The impact of COVID 19 Pandemic continued to impact on the Activities of the Organisation, however, based on financial data and recent management accounts the directors do not feel that these events will materially impact on the future development of the business


Statement on Relevant Audit Information

Accounting Records



Report on the audit of the financial statements

Opinion

We have audited the financial statements of Waterford Hospice Movement Company Limited By Guarantee ('the company') for the financial year ended 31 December 2021 which comprise the Income and Expenditure Account, the Balance Sheet, the Reconciliation of Members' Funds and notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", issued in the United Kingdom by the Financial Reporting Council, applying Section 1A of that Standard.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2021 and of its deficit for the financial year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", applying Section 1A of that Standard; and
- have been properly prepared in accordance with the requirements of the Companies Act 2014.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (Ireland) (ISAs (Ireland)) and applicable law. Our responsibilities under those standards are described below in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the company in accordance with the ethical requirements that are relevant to our audit of financial statements in Ireland, including the Ethical Standard for Auditors (Ireland) issued by the Irish Auditing and Accounting Supervisory Authority (IAASA), and we have fulfilled our other ethical responsibilities in accordance with these requirements. Conclusions relating to going concern

In auditing the financial statements, we have concluded that the directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the company's ability to continue as a going concern for a period of at least twelve months from the date when the financial statements are authorised for issue.

Emphasis of Matter

In forming our opinion, which is not qualified, we have considered the adequacy of the disclosures made in note 3 to the financial statements concerning the company's ability to continue as a going concern. Waterford Hospice Movement CLG is economically dependent on the Health Service Executive for funding. This economic dependency is underpinned through a Grant Aid Agreement between the Health Service Executive and Waterford Hospice Movement Company Limited. Accordingly, the financial statements have been prepared on a going concern basis. It is noted the impact of COVID 19 Pandemic continues to impact on the Activities of the Organisation

Based on financial data, the directors do not feel that these events will materially impact on the future development of the business

Other Information

The directors are responsible for the other information. The other information comprises the information included in the annual report other than the financial statements and our Auditor's Report thereon. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.





NOTES TO THE FINANCIAL STATEMENTS
for the financial year ended 31 December 2021

1. General Information

Waterford Hospice Movement Company Limited By Guarantee is a company limited by guarantee incorporated in the Republic of Ireland. Waterford Regional Hospital, Ardkeen, Waterford is the registered office, which is also the principal place of business of the company. The nature of the company's operations and its principal activities are set out in the Directors' Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the year ended 31 December 2021 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through profit or loss.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Income

All incoming resources are included in the Income and Expenditure Account when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. For legacies, entitlement is the earlier of the charity being notified of an impending distribution of the legacy being received. The following specific policies are applied to particular categories of income:

1. The HSE income is accounted for in the financial statements on a cash receipts basis.
2. The general fundraising income is accounted for in the financial statements on a cash receipts basis.
3. The general donations incomes accounted for in the financial statements on a cash receipts basis.
4. The interest and investment income is accounted for in the financial statements on a cash receipts basis.
5. The specific fundraising income that is received and not spent at period end are deferred to match the costs that they are intended to compensate.
6. The specific donations income that is received and not spent at period end are deferred to match the costs that they are intended to compensate.

Related parties

For the purposes of these financial statements a party is considered to be related to the company if:

- the party has the ability, directly or indirectly, through one or more intermediaries to control the company or exercise significant influence over the company in making financial and operating policy decisions or has joint control over the company;
- the company and the party are subject to common control;
- the party is an associate of the company or forms part of a joint venture with the company;
- the party is a member of key management personnel of the company or the company's parent, or a close family member of such as an individual, or is an entity under the control, joint control or significant influence of such individuals;
- the party is a close family member of a party referred to above or is an entity under the control or significant influence of such individuals; or
- the party is a post-employment benefit plan which is for the benefit of employees of the company or of any entity that is a related party of the company.

Close family members of an individual are those family members who may be expected to influence, or be influenced by, that individual in their dealings with the company.

Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

- Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes including the charity's shop.
- Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the audit fees and costs linked to the strategic management of the charity.

Fund accounting

The following funds are operated by the charity:

Restricted Funds

Restricted fund represent grants, donations and sponsorships received which can only be used for particular purposes specified by the donors. Such purposes are within the overall aim of the charity.

Unrestricted funds

Unrestricted funds represent amounts which are expendable at the discretion of the directors in furtherance of the objectives of the charity and which have not been designated for other purposes. Such fund may be held in order to finance working capital or capital expenditure.

Designated funds

Designated funds are unrestricted earmarked by the directors for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements. The designations have an administrative purpose only and do not legally restrict the boards discretion in applying the funds.

Tangible assets and depreciation

Tangible assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible assets, less their estimated residual value, over their expected useful lives as follows:

Plant and machinery	- 4% Straight Line
Fixtures, fittings and equipment	- 20% Straight Line

Assets not carried at fair value are also reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. Value in use is defined as the present value of the future pre-tax and interest cash flows obtainable as a result of the asset's continued use. The pre-tax and interest cash flows are discounted using a pre-tax discount rate that represents the current market risk free rate and the risks inherent in the asset. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows.

If the recoverable amount of the asset is estimated to be lower than the carrying amount, the carrying amount is reduced to its recoverable amount. An impairment loss is recognised in the profit and loss account, unless the asset has been revalued when the amount is recognised in other comprehensive income to the extent of any previously recognised revaluation. Thereafter any excess is recognised in profit or loss.

If an impairment loss is subsequently reversed, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the revised carrying amount does not exceed the carrying amount that would have been determined (net of depreciation) had no impairment loss been recognised in prior periods. A reversal of an impairment loss is recognised in the profit and loss account.

Stocks

Stocks are valued at the lower of cost and net realisable value. Stocks are determined on a first-in first-out basis. Cost comprises expenditure incurred in the normal course of business in bringing stocks to their present location and condition. Full provision is made for obsolete and slow moving items. Net realisable value comprises actual or estimated selling price (net of trade discounts) less all further costs to completion or to be incurred in marketing and selling.

Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other short-term highly liquid investments with original maturities of three months or less and bank overdrafts. In the Balance Sheet bank overdrafts are shown within Creditors.

Taxation

No charge to current or deferred taxation arises as the charity has been granted charitable status under Sections 207 and 208 of the Taxes Consolidation Act 1997, Charity No CHY 8998.

Foreign currencies

The accounts are expressed in euro (€).

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Income and Expenditure Account.

3. Going concern

Waterford Hospice Movement CLG has been economically dependent on the Health Service Executive for funding up to the transfer of the Community Specialist Palliative Care Home Care team to the HSE on 31 May 2021.

Funding was provided in accordance with a Grant Aid Agreement between the parties, the financial statements have been prepared on a going concern basis.

Based on recent financial performance the directors do not feel that these events will materially impact on the future sustainability of the business
