Introduction

The role of Waterford Hospice Movement (WHM) CLG has evolved, and our remit now is to provide patient comforts and supports to patients and families both in the new South East Palliative Care Centre (SEPCC) and in their own homes in the community.

The organisations origins are that it was established in 1988 to provide a Hospice Homecare Palliative Care Service to the people of Waterford City & County and South Kilkenny and it fulfilled this role until the new SEPCC was constructed with a donation of €6m from this organisation attributed to the generosity of our donors and fundraisers and the organisations commitment to fulfilling it vision of having an inpatient unit available to patients and families in the South east analogous with other regions of the country.

When the SEPCC Unit opened in 2021 the management of the Nurses for Community Homecare Palliative Care Team transferred to the HSE and our Constitution was amended to reflect our new mandate. The Charities Regulator approved this amendment in Dec 2023 and the Companies Office was also informed of the approved change in 2024. Our approved focus now is to provide public benefit to patients and their families of the Southeast Palliative Care Service in their own homes or place of residence in Waterford Community Care area, including but not limited to the Southeast Palliative Care Centre via provision of patient comforts including equipment and amenities and Complementary, Counselling and Support Services'.

We fulfil this mandate in partnership with management and staff of the SEPCC whom retain ultimate responsibility for patient care. A Legal Framework underpins the relationship between us and the HSE.

The SEPCC occupies two floors of the Dunmore Wing (Oak Ward & Beech Floor) on University Hospital Waterford campus. Developing services, supports and providing comforts on Oak Ward inpatient unit whilst simultaneously restoring complementary therapy services and other supports for patients and families in the community underpinned our activities in 2024. In this report we are delighted to provide information on how monies received via donations and fundraising on which we 100% rely, were used and how the range of services was expanded and new services introduced.

When we continued to provide daily comforts including Bean to Cup Coffee expanding the range of coffee options, and ensuring a well-stocked Refreshment Trolley was available as well as newspapers of choice, we provided a broad range of other supports and comforts including for e.g. replenishing arts & crafts materials, providing talking photo frames, hand prints sets and similar items often used for legacy making with families. Larger items of equipment such as a Lymphoedema Compression Pump as well a smaller item of equipment including replacement remote controls, Bluetooth speakers, Audio Speakers and inflatable sinks were funded. The amenities including the outdoors and indoor gardens and courtyards were maintained and enhanced. In partnership with WHA/Réalta the Healing Sounds Programme continued a new programme Creative Arts commenced. Services were expanded to include additional complementary Therapy options, a Chiropody Service and a Therapy Dog Service

WHM CLG continues to be governed by a Board of Directors and operationally managed on a day-to-day basis by its 3 parttime employees.

Chairpersons Report

I am delighted to report on the progress of WHM CLG as services developed and expanded in 2024 whilst at the same time consolidation of supports and comforts for patients and families became established.

Consistent with our vision of ensuring we steadily work towards having a level of services analogous with the level of services available in other regions of the country I am delighted to have the opportunity in this report to demonstrate our progress. I can confirm we worked on our Strategic plan 2025-2029 and I look forward to it being launched early in 2025 and having a road map for the years ahead.

In 2025 in the interest of ensuing continuity of services the Board developed a 2-year Financial Reserve should any unforeseen impact on our income which is 100% reliant on donations and fundraising occurs as was the case when the COVID-19 Pandemic occurred. This organisational resilience facilitates the expansion of existing services and development of new ones as well as sustaining day to day expenditure on patient comforts, equipment and amenities.

Our progress is underpinned by our relationship with the HSE as set out legal frameworks underpinning the €6m donation towards the construction costs of the SEPCC and I can confirm it is a pleasure to ensure mutually agreed priorities and needs for patients and families at such a difficult time in their lives are realised. In particular, I was delighted to be associated with the commencement of a new service to support carers of patients known to the community palliative care service and to be able to offer 15hrs of Carer Support Worker time to each family as recommended by the homecare team. We have legal agreements with 3 HSE approved Agencies to deliver same.

I would like to pay tribute to our Donors and fundraisers for their continued generosity and trust this report demonstrates the benefits for patients and families. Equally, the work of our Support Groups is gratefully acknowledged and appreciated.

I would also like to take this opportunity to acknowledge the work of our Trustees who give so generously of their time to ensuring the organisation is properly governed and supported, and finally I wish to acknowledge the commitment of the Management Team who look after the day-to-day operations. We were delighted to appoint a Clerical Grade 111 part time post mid-year to support our expansion of services and supports for patients and families.

Managers' Report

The focus in 2024 was to continue to sustain core activities in terms of providing patient comforts, equipment, amenities, and supports for patients and families on Oak ward inpatient unit and patients in their own homes in the Community as well as expanding them adding new support options as agreed with the SEPCC clinical and managerial team.

In addition to the leadership and support of the Board, the support, leadership and direction of our Chairperson Barbara Murphy who attended regular Operational Meetings with the team was invaluable. Mid-year we were delighted to welcome Cara Harte as a part time Grade 111 and who has made an excellent contribution to enhancing the expansion of our work.

The aim of creating a sanctuary-like experience for patients and their families on Oak Ward ensuring an atmosphere of ambiance and optimum relaxation is central to our activities. Comforts and supports on Oak Ward will be detailed in this report but importantly on a daily basis include good quality coffee from our state-of-the-art bean to cup coffee machine as well as a range of teas, treats and newspapers- all to be consumed in the patient's room or in any of the comfortable surroundings and with quiet spaces both in the unit or in the gardens and courtyards. The children's play area and facilities helped keep the little ones entertained and occupied.

We were delighted to commence the hairdressing service, and both hairdressers Yvonne and Nicola greatly enhanced the wellbeing and feel-good factor for the patients. Our Complementary Therapies expanded to include Acupuncture and Craniosacral Therapy and the Reflexology service for patients in their own homes was restored having ceased during COVID-19 pandemic.

The new Home Support for Carers service commenced at the end of 2024 providing support for carers. We look forward to this service growing as the numbers of patients and families known to the homecare team expanded in 2024 and is expected to continue to grow in 2025. A Chiropody Service also commenced and is available both in the unit and to patients in their own homes. Another new addition was the Dog Therapy service and Nuada and his owner Fergal are received with great delight in the unit on their weekly visits.

Our collaboration with WHA/Réalta expanded in 2024 with the continuation of the Healing Sounds Programme for the patients and families on Oak Ward and commencement of funding for a Creative Arts Programme. This new programme is very well received by patients and their families, complementing their experience in terms of creating treasured memories and legacies.

Equally our collaboration with Deise Women's Shed who knit or crochet the Blankets of Hope which remain with the family following the death of their loved one if desired as well as a crochet red heart



The aim in 2025 is to continue to expand in line with our Strategic Plan 2025-2029 which will be launched in early 2025

Communications & Fundraising Managers Report



In 2024 we continued our membership of **Together for Hospice**, the umbrella organisation for 26 hospices nationwide. We would like to thank Together For Hospice for their support of Sunflower Days (June) and Bewley's Big Coffee Morning for Hospice (September). All monies raised locally through these campaigns stays locally and both continue to be major fundraising events in terms of coordination and income each year.

For **Sunflower Days 2023** we had representation in venues around the city, as well as Tramore and Dungarvan with approx. 200 volunteers in total. I would like to take this opportunity to thank all our wonderful volunteers and supports groups for their continued support, without whom Sunflower Days would not happen each year.





In 2024 saw our 32nd **Bewley's Big Coffee Morning** for Hospice and the launch was held in Bewley's Café, Grafton Street with Dermot Gleeson as Ambassador. The response to this year's Bewley Big Coffee Morning for Hospice was outstanding with so many hosts organising Coffee Mornings raising €67k for Waterford Hospice and over €2m for hospices nationwide which is deeply appreciated.

There was a huge increase in **Fundraising Events** throughout 2024, many held by families in memory of their loved one and what a wonderful way to celebrate their lives and at the same time supporting Waterford Hospice. This year Fundraising events raised in excess of €263k for Waterford Hospice. We are so grateful to all our event holders both past and present for their massive generosity.





As has been the case since 1988 we continued to collaborate with **Waterford Rotary Club** on their Annual Memorial Christmas Tree appeal. The overall income is shared with Solas Cancer Support Centre, this is a great way for people to remember a loved one at Christmas time while supporting their local hospice and cancer support centre.

In response to the change in how people donate and the move away from cash our plan in 2025 is to purchase Sum Up machines to have at all our major fundraising events.



In 2024 we introduced our **Quarterly Newsletter** to keep all our supports and fundraisers up to date on how funds raised are being spent and we also find this a great way to acknowledge all the great work of our support groups and volunteers.

Sale of our Christmas Cards continues to be highly supported, and we remain grateful for all the general donations via our website, cash & cheques, iDonate fundraising events, bequests and legacies, counter boxes and 'Text to Donate' campaign etc.

Governance, Legal & Administrative Details

WHM is a Company Limited by Guarantee (CLG). Accordinly its Annual Accounts and Financial Statements are filed with the Compnaies Registration Office (CRO). Our Company No. 136829.

M.K. Brazil & Co https://www.mkbrazil.com/ undertook our Annual Audit and prepared our Annual Financial Reports and Financial Statements for review and approval at AGM 2025

WHM is a Registered Charity and our Charity Number is 20022495. Following approval of the 2023 Accounts these were filed AGM with Charities Regulator www.charitiesregulator.ie as required and with the Companies Registration Office (CRO)consistent with legal requirements. All Annual Accounts are published on our website.

WHM is Registered for Revenue on Line services (ROS) and is deemed eligible for Tax Relief on Donations for Eligible Charities Scheme – CHY No 8998 and we communicate with all donors whom gave donation >€250k annually and this income is clearly recorded on our Annual Accounts and Financial Statements

Our Payroll and Accounting function is outsourced to an independent Company RKD Accounting (formerally APBS) https://www.rda.ie/ since June 2021.

WHM operastes in a formal partnership arrangment with the HSE /SEPCC in accordance with the provisions of a Memorandum of Undertanding (MOU) 2016 which specifies 'The HSE and Waterford Hospice will jointly participate in a Partnership Forum that will advise on the running (including ethos, standards and protocols) of the facility'. Similarily, a Legal Agreement (May 2018) specifies 'The HSE and The Donor will jointly participate in a partnership forum that will advise on the operation of the Palliative Care Facility. A total of 5 Partnership Meetings were held in 2024.

Board Meetings were held regularily throughout the year. In addition the management team were supported by regular operational meetings with the Chairperson and with support from individual Directors as/when required.

The functionality of CHAMP https://champcloud.com/ our CRM system as a dedicated system for Charities and Not-for-Profits continued to be optimised in 2024 with additional integrations to optimise transparency and reporting of combined income for individual fundraising events. For example, we can now receive income from multiple platforms for one fundraising event and these amounts are uploaded to Champ and recorded under the Donor's name, thus optimising accuracy, transparency and accountability for individual fundraising event.

All online donations to our website continued to be processed using Stripe Technology https://stripe.com/ie directly to our AIB Current Account and overall focus remained on systems to optimise non-cash-based income. Vitamin provided Web Design as well as technical support and support with Branding for Inpatient information leaflet, Patient feedback forms and Information leaflets for patients and families in the community.

WHM continues to operate a Text to Donate campaign in accordance with its Licence from ComReg https://www.comreg.ie/

Radius Technologies https://radius.ie/ continued to provide ICT and Telecoms support.

WHM is a membership of Together for Hospice (TFH) https://www.togetherforhospice.ie/ as the national fundraising body for 26 Hospice and Specialist Palliative Care Providers in Ireland

An additional parttime employee commenced at end of May 2024 increasingly WHM staffing to 3 part time employees

Southeast Palliative Care Centre (SEPCC)

The Centre consists of the Oak Ward which is the 20 bedded inpatient unit and also Beech Floor where outpatients are currently seen and where day services will be available in future years. In 2024 we expanded comforts and supports commenced in previous years and commenced new initiatives. We will provide a snapshot of some of the comforts in this section as the range of items requested is vast and includes items such as replacement remote controls, Bluetooth speakers, Audio and DAB internet speakers ,iPad Holders, inflatable basins for washing hair at the bedside, mirrors, handheld fans, suncream and sun hats, Ear Pressure area pillows, LED timer lights to name a few!




Development Care & Maintenance of the Outdoor Gardens, Courtyards and Indoor Plants


An average of 4 families /month availed of this service.

Patients at home were also offered Complementary Therapy and Chiropody Services in 2024


Bereavement Services



Complementary Therapy Services

Restoration of Complementary Therapy Services for patients known to Waterford Community Specialist Palliative Care Team was achieved in 2024 having ceased due to the impact of the COVID 19 pandemic. Accordingly, patients at home, on Oak Ward, or on Beech Floor or at Dungarvan Primary Care Centre had access to the options of Reflexology and Acupuncture and the following graph represents this activity and the locations for same





Review of Income Trends 2019-2024.





Each year WHM receives Income from this source. We are very grateful to all whom consider making these bequests to support the continued development of Specialist Palliative Care Services.



Charity Tax Back Scheme


Cert if the donation is made each year over a 5-year period an Annual Certificate – CHY4 Cert if the donation is a Once off donation.

Income Trends Bewley's Big Coffee Morning Social for Hospice - WHM Event



National Sunflower Day


Sunflower Day is held each June. This is a national campaign by Together for Hospice and managed locally by WHM Team.



East meets West Lions Club Annual Cycle



Overall Summary of Income from Annual Events


This Table demonstrates Income proportions for main Annual Events for the 5yerar period 2020-2025





Risks and Challenges

The Risk register was reviewed at each Board Meeting and actions were taken to ensure compliance with legal and regulatory requirements

Risk in respect of security and continuity of the organisation as well as increasing workload concerns were mitigated by the decision in Q4 to recruit an additional part time employee at Grade 111 Clerical Officer grade and e were delighted to welcome Cara Harte to the team in May 2024

The Board approved the retention of Adare HR to assist with review and finalisation of the Dept Safety Statement and work is ongoing in respect of same.

The Board intends to publish its Strategic Plan in early 2025 setting the priorities for the years ahead and a specific commitment to focus on increasing Supports to patients and families in their own homes in the Community as well as continuing to develop the range and level of supports for patients and families in the SEPCC.

- Continue Hairdressing Services for patients known to SEPCC.
- Continue access to Chiropody Services for Inpatients and for patients in the community
- Fund Beautician and Nail care Service if/as requested by inpatient Unit
- Continue and potentially expand Therapy Dogs Service
- Continue maintenance of the outdoor gardens, courtyards maintenance of the Indoor plants.
- Continue to Fund monthly costs of Garden Maintenance, Daily/Weekly Newspapers, Coffee Beans and Coffee Cups, Additional Food and Beverages for inpatients, provision of nightwear and toiletries, Activity Packs, Books on Bereavement for children and families.
- Continue to fund Once off requests for funding consistent with our updated Charitable
 Objects as requested by SEPCC
- Continue to purchase Mouth Care treatment Packs for patients know to the Community Specialist Palliative Care Service
- Progress commencement of a Counselling Service for patients & families with nonmalignant diagnoses in partnership with the SEPCC
